BACKGROUND OF THE IDEA OF THE NEW CLASS

- NEED TO EXPLAIN THE PHENOMENON OF "POWER WITHOUT PROPERTY" OR POWER WITHOUT "TRADITIONAL AUTHORITY."
- 2. TERM "NEW CLASS" EMPLOYED IN 1956 BY MILOVAN DJILAS TO LABEL COMMUNIST RULERS.
- 3. TERM FIRST APPLIED TO U.S. BY DAVID T. BAZELON IN 1967.
- 4. TERM USED, MORE OR LESS IN OUR SENSE, BY D.P. MOYNIHAN AND NORMAN PODHORETZ IN 1972. INTERPRETED, CIRCULATED, AND PUBLICIZED BY IRVING KRISTOL.
- 5. TERM NOW WIDELY USED--E.G., RECENT ARTICLES IN FORTUNE, THE NEW REPUBLIC, THE PUBLIC INTEREST, THE NEW YORK TIMES, HARPERS, ATLANTIC MONTHLY, ETC.
- 6. WIDESPREAD BELIEF THAT NEW CLASS WILL BE THE DOMINANT CLASS IN THE FUTURE.

OUR USE OF THE TERM NEW CLASS

THE NEW CLASS IS LARGELY COMPOSED OF UPPER MIDDLE CLASS INTELLECTUALS WHO ARE INCREASINGLY IN POSITIONS OF POWER AND INFLUENCE IN THE U.S. THEIR SOURCES OF POWER AND INFLUENCE DIFFER FROM THOSE OF THE OLDER UPPER CLASS AND UPPER MIDDLE CLASS ELITE WHOSE BASE HAS BEEN TRADITIONAL PRESTIGE ASSOCIATED WITH WEALTH AND PROPERTY OR HIGH POSITION IN BUSINESS AND GOVERNMENT.

AS A WHOLE, THE NEW CLASS DERIVES BOTH ITS INFLUENCE AND INCOME FROM POSSESSION AND MASTERY OF VERBAL, SYMBOL, AND "PERSUASIVE" SKILLS. SKILLS ENGENDERED MORE BY FORMAL ACADEMIC AND ANALYTICAL TRAINING THAN BY PRACTICAL TRAINING AND EXPERIENCE. NEW CLASS PEOPLE TEND NOT TO SPECIALIZE IN ENTREPRENEURIAL, ENGINEERING (ESPECIALLY CIVIL AND POWER) OR ADMINISTRATIVE SKILLS. NOR DO THEY, NORMALLY, EXERCISE CLERICAL OR MANUAL SKILLS AS A MEANS OF LIVELIHOOD.

WE DISTINGUISH FIVE SUBDIVISIONS OF THE NEW CLASS: TRADITIONAL CON-SERVATIVE, NEO-CONSERVATIVE, TRADITIONAL LIBERAL, NEO-LIBERAL, AND HUMANIST LEFT. IT IS THE NEO-LIBERAL SUBGROUP WHICH WE BELIEVE NEEDS MOST TO BE CRITICALLY EXAMINED AT THIS TIME.

MOSTAS IMAGEO OF THERE IS AN EMERGING NEW CLASS IT SHOULD BE IDENTIFIED BY:

- HIGH FORMAL EDUCATION
- RESPECTABLE SOCIAL ORIGINS
- HIGH PERCENT HAVING "PROFESSIONAL" OCCUPATIONAL STATUS
- HIGH (BUT NOT HIGHEST) INCOME. (IF INVOLVED IN MANUAL SKILLS IT IS AS PART OF THE "VOLUNTARY SIMPLICITY" MOVEMENT OR RELATED TO THE SELF-FULFILLMENT ETHOS. IF LOWER INCOME, THIS MAY BE BECAUSE STILL A STUDENT OR WORKING FOR A LOW PAYING PUBLIC INTEREST GROUP)
- TYPICALLY SOURCE OF INCOME IS FROM A NON-MARKET ORIENTED SOURCE SUCH AS:
