2. If found physically qualified, and upon acceptance of appointment in the U. S. Naval Reserve, you will immediately report to your commanding officer for temporary active duty. When directed by your commanding officer, on 16 September 1944, you will regard yourself detached; proceed to Princeton, N. J., and report to the Commanding Officer, Naval Training School (Indoctrination), Princeton University, for temporary active duty under instruction.
3. You are hereby authorized to delay until 25 September 1944 in reporting at Princeton, N. J., in compliance with these orders, such delay to count as leave.
