Dear Family,

Negotiations with Smith International are going well. We expect to reach an agreement within the next 6 weeks and to complete the deal within 4 months.

Other companies are still interested and we continue to work with them. Smith is the best possibility so far.

They will keep Megadiamond independant but have a division that concentrates on Smith products which I will head and another which will concentrate on outside markets which Duane will head. Tracy and Dad will work in my division.

I have enclosed a schedule showing each of you how much stock you have, what we will be gifting to Tracy Jr., and how much we will each have if the company sells for \$8 million or \$10 Million.

Smith will be purchasing my drilling application company which I started when I moved to Provo in 1976 and which I have continued to work with until now. Purchase price for DHD will be 5% of the total deal with Megadiamond. I have also recieved stock option instead of cash bonuses over the years and I will be turning these options in at the time of the sale.

I have not yet figured out if it is best to make the gift to Tracy prior to the merger or after or exactly the best way to do it. At any rate, we all agree with the idea. I'll let you know more details later.
