


Enclosed is a check representing the final portion of Smith International's ("Smith") payment of the judgment in the above-noted matter. We have also enclosed an itemized accounting for the disbursement of this judgment. Please note that while attorneys' fees and costs were deducted from the first disbursement, no similar deduction has been made from the second disbursement.

Though we have continued to accrue fees in representing you in Smith's pending appeal, we have already recently reached an agreement with Smith for payment of attorneys' fees and costs in the amount of \$90,000. Once this amount is received, we will draw on it for the fees and costs incurred for the appeal with the remaining amount being returned to each former shareholder based on their proportionate ownership interest. Finally, ultimate success in this appeal should allow us to seek attorneys' fees and costs associated with it.
