## THE GENEALOGY SOCIETY - IT'S ALL RELATIVE

I had long believed that a pursuit as esoteric as genealogy was something carried out in isolation. While the research methods were common it was always their own ancestors and my own ancestors, and the two were never the same people. When I found out that the Tracy ancestors of a friend of mine, and WCGS member, Sherlene Bartholomew, lived right across the street from my Lathrop ancestors in Norwich, Ct., some 325 years ago I was not prepared for the indescribably strange feelings I experienced. That the paths of two different families, who had been neighbors in times long past, should cross again after eleven generations was, to me, extraordinary. It was not an event that I had ever considered or expected but which was very exciting to experience. This is my first indication that someone actually knew these people. That they were real people - not just names in a book.

Last spring I was at one of the Genealogy Society meetings and Sherlene was sitting next to me. As the committee reports droned on and on, and as the chair seemed to get harder and harder, Sherlene gave me a lineage chart and said that she had discovered some more Connecticut ancestors. As I went down the list of names on the chart I came to John Hall and Jane Woolen of New Haven and Wallingford. Hey, these are my ancestors! I finally had a relative located through genealogy. Sherlene and I are 9th cousins through our Hall family connection and we have since found another connection through Capt. Nathaniel Merriman (Merriam) another early settler of Wallingford.

By using the Surname List I have since found that I am related to Jean MacIntosh through Paul Peck of Hartford and his wife Martha Hale. Jean had Martha's maiden name and the names of her parents, Thomas Hale and Joan Kirby. This was new information for me. Lois Lober, who arranges our field trips, turns out to be a cousin through the family of Robert Seabrook and Alice Goodspee, who married in England in 1596. This is the first time that I've found a cousin where our common ancestry does not begin here in America. On the Surname List Thelma E. Smith and I matched on 13 names. At least seven of these lines are common ancestors. I knew of Samuel Sedgwick and Mary Hopkins and Thelma gave me information that added the Stone, Blake, Howe, Strong and Bronson families to my growing list of surnames. Since I haven't had the opportunity to really check with all of the 18 WCGS members who had surnames matching my own I am sure future surprises await.

In November I had some displays at the meeting, including the will of George Hubbard. Barbara Beaudry walked up and said that George Hubbard was an ancestor of her's as well. Since then we have been unable to reconcile our information about George Hubbard but the debates have been great fun. It now appears that there were two Georges, who were contemporaries, but that genealogists have been confusing them as the same person, or as father and son, for generations. Along the way we found common ancestors in the Bulkeley family of Fairfield, Ct., and Concord, Mass., and have been adding to each other's knowledge of that family, and its royal connections, back into the early middle ages - some fifty-one generations ago!
