Last Saturday we went with Hobart Bartlett (a retired chemist widower in the ward) to Richmond, to do some genealogy. Brother Bartlett is a very fast, but not very accurate driver, which I think gave Virginia the fits. I wasn't concerned, however; I figured that if his Chevy had gone 16 years and 210,000 miles without a dent it must be because the Lord was protecting him and preserving him for the duration of his mission.
