Dear family,

Since Mom Hall offered to buy our Payson home for 43,000.00 (if worst-came to worst,) we went ahead and started hunting for a new home in the provo-oreem area. We finally found the one we wanted! It had a double garage for Doug... 6 apple trees on the large lot... a fireplace... antique brown brick facing with barnwood trim... 2 bedrooms upstairs... full unfinished bsmt. Built in dishwasher, U-shape kitchenette with eating bar... a study-desk... fancy lighting fixtures... Sliding glass doors with a porch, and more! all this, for \$55,400. - ... which we felt was a real reasonable price! ... So we arranged for a loan. Our loan officer went ahead and processed our loan... only one problem... we hadn't sold our Payson home yet. He asked us if there were any prospective buyers... And we told him that my mother offered to buy it as a last resort at 43,000.00. His ~~eyes~~ bugged out, and without

I am no longer working at Reams. Mr. Reams decided that I should start working 60 hrs. a week, assume all responsibilities including store detective (including testifying in court if necessary), receiving orders, taking inventory, buying, advertising, hiring, firing, sales, stocking shelves, straightening and more - without a raise. Well, he did give me a raise for 1,200.00 a month. then he decided he was over-paying me - so he DEDUCTED what he thought he had over-paid me from my next paycheck - which was around 300.00. I raised the roof on that! ... so he said he'd make it right with me. He gave me a 25¢ raise per hour.
