Gentlemen:

I went to Salt Lake City and talked with United Air Lines air freight people yesterday. They now tell me that the shipment can not go air freight because pallets #1 and #2 are too large. Pallet #2 could be rewade (with difficulty) to rest on its side but nothing could be done to make pallet #1 which contains the main part of the press shipable by air (50 inch limit on height). Wide-body jets carry freight in the plane's belly and 50 inches is their limit. The weight is not a problem - just the physical size and shape. Consequently, I will go ahead with arranging ocean transport to the port of Bombay ~~and overland to New Delhi~~ as soon as possible.
