Gentlemen:

I am sorry for the delay in the shipment of the 200 ton cubic press.

It is caused by delays in obtaining the 50 cycle electrical equipment that was ordered May 1, 1974. We have been able to obtain 50 cycle motors but have not been able to obtain the remaining 50 cycle components.

In desperation, one week ago we engaged the services of an engineer who is designing a way around the problem by using silicon controlled rectifier electronics to replace the 50 cycle equipment that has not been delivered. Also, a new hydraulic system is being built to circumvent the 50 cycle problem there.

I apologize for the delay but the matter is beyond our control.

To avoid additional contractural problems, we will give to you free of charge the 250 additional special loaded sample cells requested by Dr. Agarwala.

We can not supply a complete list of components, spares, and supplies until about January 20, 1975 due to the changes that are being made. We expect to ship about February 10, 1975. We have talked with United Air Freight, Salt Lake City. Air Freight on the 200 ton cubic press to Bombay would cost about \$4,000.00 and would take 7 days. They say that it could not be air freighted into New Delhi. You might want to consider shipping this way to make up for the delays.
